1. The information provided in this application is true, complete, and accurate, and is submitted for the purpose of obtaining credit.
 2. Customer agrees to pay all invoices issued by **Prather Power Services** according to the terms stated on each invoice (Net 15 unless otherwise specified).
- a. Pricing for fuel and services is subject to market conditions and may change without prior notice.
b. Payment terms are as stated on each invoice.
c. A fee of **\$35.00** will be assessed for any returned or declined payment.
3. Any past due balance will be subject to a **finance charge of 1.5% per month (18% annually)** or the maximum rate allowed by law, plus a **\$35.00 late fee per invoice**. Prather Power Services reserves the right to suspend service or require prepayment for any account that becomes past due.
 4. In the event of non-payment, Customer agrees to pay all costs of collection, including but not limited to **collection agency fees, attorney fees, court costs, and any related expenses**. The undersigned agrees that by execution of this agreement, he/she/they are **personally liable, jointly and severally**, for all indebtedness incurred by the Customer. Demand for payment and notice of default are expressly waived.
 5. Customer authorizes **Prather Power Services** to verify any trade references, bank references, or credit information listed on this application and authorizes the release of such information for the purpose of determining credit eligibility.
 6. **Service & Liability Terms**
 - a. Customer is responsible for providing safe and accessible delivery conditions at the service location.
 - b. Customer assumes responsibility for verifying fuel type, quantity, and equipment compatibility prior to delivery.
 - c. Prather Power Services shall not be liable for damages resulting from incorrect information provided by Customer, equipment failure unrelated to fuel quality, or conditions outside of its control.
 - d. Customer agrees to indemnify and hold harmless Prather Power Services from any claims, damages, or losses arising from Customer’s equipment, site conditions, or misuse of fuel.

7. **Jurisdiction**

This agreement shall be governed by the laws of the **State of Florida**, and Customer agrees to jurisdiction and venue in Florida for any disputes arising from this agreement.
